iSPACE Terms of Use

These Terms of Use (“Terms”) govern your access to and use of the iSPACEstem.org website (the “Website”) and the iSPACE mobile applications and Services (collectively, the “Services”). You agree that by visiting the Services or by registering or using the Services, you are entering a legally binding agreement with iSPACE, Inc., located at 100 Scarlet Oaks Dr., Cincinnati, OH 45241 (“iSPACE”) based on the Terms and the Privacy Policy, which is hereby incorporated by reference (collectively referred to as the “Agreement”). Your access to and use of the Services are conditioned on your acceptance of and compliance with the Agreement. By accessing or using the Services you agree to be bound by the Agreement.

1. Basic Terms

iSPACE is a non-profit organization providing educational services and camps to children, school groups, scout groups, and other similar groups to foster interest and experience in science, technology, engineering, and mathematics. iSPACE offers in-house opportunities and travels to local schools to bring science to students wherever they may be. Our programs require we take special care to control the use and privacy of information exchanged online, especially information of children.

You are responsible for your use of the Services and for any consequences thereof. You may use the Services only if you can form a binding contract with iSPACE and are not a person barred from accessing the Services under the laws of the United States or other applicable jurisdiction. If you are under 18 years of age you may only access or use the Services under the direct guidance and supervision of a parent or guardian who has accepted the Agreement on your behalf. If you are under 13 years of age you may not use the Services for any reason. Please contact us if you are aware that a person under 13 is using the Services. You may use the Services only in compliance with these Terms and all applicable local, state, national, and international laws, rules and regulations.

The Services are always evolving, and the form and nature of the Services may change from time to time without prior notice to you. In addition, iSPACE may stop (permanently or temporarily) providing the Services (or any features within the Services) to you or to users generally and may not be able to provide you with prior notice. We also retain the right to create limits on use and storage at our sole discretion at any time without prior notice to you.

The Services may include advertisements, which may be targeted to the content or information on the Services, queries made through the Services, or other information. The types and extent of advertising on the Services are subject to change. In consideration for iSPACE granting you access to and use of the Services, you agree that iSPACE, third party providers and partners may place such advertising on the

2. Privacy

Any information that you provide to iSPACE is subject to our Privacy Policy, which governs our collection and use of your information. You understand that through your use of the Services you consent to the collection and use (as set forth in the Privacy Policy) of this information, including the transfer of this information to the United States and/or other countries for storage, processing and use by iSPACE. As part of providing you the Services, we may need to provide you with certain communications, such as service announcements and administrative messages. These communications are considered part of the Services and your iSPACE subscription, which you may not be able to opt-out from receiving.

3. iSPACE's Rights

All right, title, and interest in and to the Services and any content available on the Services are and will remain the exclusive property of iSPACE and its licensors. The Services and its content are protected by copyright, trademark, and other laws of both the United States and foreign countries. iSPACE reserves all rights not expressly granted in these Terms. You acknowledge and agree that any feedback, comments, or suggestions you may provide regarding iSPACE, or the Services are entirely voluntary, and we will be free to use such feedback, comments or suggestions as we see fit and without any obligation to you.

4. Restrictions On Use Of The Services

We reserve the right at all times (but will not have an obligation) to suspend and or terminate users or reclaim usernames without liability to you.

We will make reasonable efforts to notify you by the email address associated with your subscription.

8. GENERAL TERMS. Waiver and Severability

The failure of iSPACE to enforce any right or provision of these Terms will not be deemed a waiver of such right or provision. In the event that any provision of these Terms is held to be invalid or unenforceable, then that provision will be limited or eliminated to the minimum extent necessary, and the remaining provisions of these Terms will remain in full force and effect.

A. Controlling Law and Jurisdiction

These Terms and any action related thereto will be governed by the laws of the State of Ohio without regard to or application of its conflict of law provisions or your state or country of residence. All claims, legal proceedings or litigation arising in connection with the Services will be brought solely in the federal or state courts located in Hamilton County, Ohio, United States, and you consent to the jurisdiction of and venue in such courts and waive any objection as to inconvenient forum. You agree that you may only bring claims against iSPACE related to your use of the Services on an individual basis and not as a plaintiff or class member in any purported class or representative action or proceeding.

B. Entire Agreement

These Terms and our Privacy Policy are the entire and exclusive agreement between iSPACE and you regarding the Services (excluding any service for which you have a separate agreement with iSPACE that is explicitly in addition or in place of these Terms), and these Terms supersede and replace any prior agreements between iSPACE and you regarding the Services.

We may revise these Terms from time to time, the most current version will always be at iSPACEstem.org. If the revision, in our sole discretion, is material we will notify you via email to the email associated with your subscription or through the Services. If you do not wish to be bound by any such revisions to the Terms, you must end these Terms with us as set forth in Section 6 above. By continuing to access or use the Services after those revisions become effective, you agree to be bound by the revised Terms.
